**CONSOLIDATED FUND APPROPRIATION ACT

**An Act for the appropriation of \$31 708 000 out of the Consolidated Fund for the services of the Parliament and Statutory Offices for the financial year ending on 30 June 2019**

**[Royal Assent 20 July 2018]**

Be it enacted by Her Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:

**1. Short title**

This Act may be cited as the *Consolidated Fund Appropriation Act (No. 2) 2018*.

**2. Commencement**

This Act is taken to have commenced on 1 July 2018.

**3. Issue, application and appropriation of \$31 708 000**

- (1) In respect of the financial year ending on 30 June 2019, the Treasurer may –
  - (a) issue the sum of \$31 708 000 out of the Consolidated Fund; and
  - (b) apply that sum for the services of the Parliament and Statutory Offices.
- (2) The sum specified in subsection (1) is appropriated.

**4. Purposes of appropriation**

The sum specified in section 3(1)(a) is to be applied for the purposes specified in Schedule 1.

**5. Expiry of Act**

This Act expires on 30 June 2020.
