TERRORISM LEGISLATION (EXTENSION) ACT 2025

An Act to extend the operation of the *Police Powers (Public Safety) Act 2005* and the *Terrorism (Preventative Detention) Act 2005*

[Royal Assent 23 December 2025]

Be it enacted by Her Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:

PART 1 – PRELIMINARY

1. Short title

This Act may be cited as the *Terrorism Legislation (Extension) Act 2025*.

3. Principal Act

In this Part, the *Police Powers (Public Safety) Act 2005** is referred to as the Principal Act.

4. Section 34 amended (Expiry of Act)

Section 34(1) of the Principal Act is amended by omitting “31 December 2025” and substituting “31 December 2030”.

5. Principal Act

In this Part, the *Terrorism (Preventative Detention) Act 2005** is referred to as the Principal Act.

6. Section 54 amended (Sunset provision)

Section 54 of the Principal Act is amended as follows:

- (a) by omitting from subsection (1) “31 December 2025” and substituting “31 December 2030”;
- (b) by omitting from subsection (2) “31 December 2025” and substituting “31 December 2030”.
