1. Short title

These regulations may be cited as the *Marine and Safety (Infringement Notices) Amendment Regulations (No. 2) 2017*.

2. Commencement

These regulations take effect on the day on which the *Marine and Safety (Maritime Incidents) Regulations 2017* take effect.

3. Principal Regulations

In these regulations, the *Marine and Safety (Infringement Notices) Regulations 2008** are referred to as the Principal Regulations.

4. Regulation 6 amended (Offences under *Marine and Safety (Maritime Incidents) Regulations 2017*)

Regulation 6(1) of the Principal Regulations is amended by omitting “*Marine and Safety (Maritime Incidents) Regulations 2007*” and substituting “*Marine and Safety (Maritime Incidents) Regulations 2017*”.

5. Schedule 3 substituted

Schedule 3 to the Principal Regulations is rescinded and the following Schedule is substituted:
