**1. Short title**

These regulations may be cited as the *Evidence (Audio and Audio Visual Links) Regulations 2018*.

**2. Commencement**

These regulations take effect on the day on which their making is notified in the *Gazette*.

**3. Interpretation**

In these regulations –

*Act* means the *Evidence (Audio and Audio Visual Links) Act 1999*.

#### **4. Certain tribunals prescribed as Tasmanian courts**

The following tribunals are prescribed as Tasmanian courts for the purposes of the definition of *Tasmanian court* in section 3 of the Act:

- (a) Asbestos Compensation Tribunal;
- (b) Forest Practices Tribunal;
- (c) Guardianship and Administration Board;
- (d) Health Practitioners Tribunal;
- (e) Legal Profession Disciplinary Tribunal;
- (f) Mental Health Tribunal;
- (g) Motor Accidents Compensation Tribunal;
- (h) Property Agents Tribunal;
- (i) Resource Management and Planning Appeal Tribunal;
- (j) Tasmanian Industrial Commission;
- (k) Tasmanian Planning Commission;
- (l) the Tribunal constituted under section 12 of the *Anti-Discrimination Act 1998*;
