1. Short title

These regulations may be cited as the *Taxi and Hire Vehicle Industries (Review of Decisions) Amendment Regulations 2018*.

3. Principal Regulations

In these regulations, the *Taxi and Hire Vehicle Industries (Review of Decisions) Regulations 2010** are referred to as the Principal Regulations.

4. Schedule 1 amended (Administrative decisions)

Schedule 1 to the Principal Regulations is amended as follows:

- (a) by omitting “*Taxi Industry Regulations 2008*” from column 2 of item 8A in Part 1 and substituting “*Taxi Industry Regulations 2018*”;

- (d) by omitting “regulation 13(j) of the *Taxi Industry Regulations 2008*” from column 2 of item 18B in Part 1 and substituting “regulation 13(i) of the *Taxi Industry Regulations 2018*”;
