In these regulations, the *Litter (Infringement Offences) Regulations 2011** are referred to as the Principal Regulations.

4. Schedule 1 amended (Infringement Offences and Penalties)

EXPLANATORY NOTE

(This note is not part of the regulations)

These regulations amend the *Litter (Infringement Offences) Regulations 2011*, consequent on the enactment of the *Litter Amendment Act 2019*, to include offences under sections 9 and 9A of the *Litter Act 2007* as infringement offences and specify in relation to each such infringement offence the penalty that is payable under an infringement notice.
