**PROCLAMATION UNDER THE ROADS AND
JETTIES ACT 1935**

STATUTORY RULES 2019, No. 81

I, the Governor in and over the State of Tasmania and its Dependencies in the Commonwealth of Australia, acting with the advice of the Executive Council, by this my proclamation made under section 7 of the *Roads and Jetties Act 1935* –

- (a) declare the portions of road specified in Schedule 1 to this proclamation to be a subsidiary road, classified as a developmental road, for the purposes of Part II of that Act; and
- (b) declare that the portion of road specified in Schedule 2 to this proclamation ceases to be a subsidiary road for the purposes of Part II of that Act; and
- (c) amend the proclamation notified in the *Gazette* as Statutory Rules 1970, No. 67 as follows:
 - (i) by omitting from Part I of The Second Schedule to that proclamation the item relating to Lilydale Main Road and substituting the following item:

Lilydale	From the East Tamar Highway at Rocherlea to the northern boundary of its intersection with the Prossers Developmental Road, via George Town Road and Lilydale Road	6.24 (10.04 kilometres)

- (ii) by inserting in Part IV of The Second Schedule to that proclamation, in the correct alphabetical position, the following item:

Prossers	From its intersection with the Tasman Highway at Nunamara to its intersection with Lilydale Road, via Patersonia Road and Prossers Road	8.60 (13.84 kilometres)

- (d) revoke the proclamation notified in the *Gazette* as Statutory Rules 1979, No. 166; and
- (e) revoke the proclamation notified in the *Gazette* as Statutory Rules 1993, No. 232, only insofar as it relates to the Lilydale Main Road; and
- (f) declare that this proclamation takes effect on the day on which its making is notified in the *Gazette*.

EXPLANATORY NOTE

(This note is not part of the proclamation)

This proclamation –

- (a) declares portions of certain roads (known as Prossers Developmental Road) as a subsidiary road, with the classification of developmental road; and
- (b) declares that a portion of Lilydale Road ceases to be a subsidiary road; and
- (c) consequentially amends an earlier proclamation (S.R. 1970, No. 67) in respect of the description and length of Lilydale Main Road and inserts into that proclamation an item relating to the new subsidiary road known as Prossers Developmental Road; and
- (d) revokes all, or part of, certain proclamations in respect of Lilydale Road.
