TRAFFIC (COMPLIANCE AND ENFORCEMENT) AMENDMENT (GRADUATED LICENSING) REGULATIONS 2020

1. Short title

These regulations may be cited as the *Traffic* (Compliance and Enforcement) Amendment (Graduated Licensing) Regulations 2020.

2. Commencement

These regulations take effect on 1 December 2020.

3. Principal Regulations

In these regulations, the *Traffic (Compliance and Enforcement) Regulations 2017** are referred to as the Principal Regulations.

4. Regulation 3 amended (Interpretation)

Regulation 3(1) of the Principal Regulations is amended by omitting the definition of RR and substituting the following definition:

RR means the *Road Rules*;

5. Schedule 1 amended (Offences)

Schedule 1 to the Principal Regulations is amended as follows:

(a) by inserting after paragraph (b) in item 414 in Subdivision 45 of Division 2 of Part 1 the following item:

414A. RR Drive vehicle under learner licence, or P1 300(1A) provisional licence, while using mobile phone when vehicle moving or stationary, but not parked

(b) by omitting "L1 stage or L2 stage" from column 3 of item 510 in Subdivision 1 of Division 2 of Part 2 and substituting "novice driver learner stage";

- (c) by omitting "L1 stage or L2 stage" from column 3 of item 511 in Subdivision 1 of Division 2 of Part 2 and substituting "novice driver learner stage";
- (d) by omitting "L1 stage or L2 stage" from column 3 of item 512 in Subdivision 1 of Division 2 of Part 2 and substituting "novice driver learner stage";
- (e) by omitting "L1 stage or L2 stage" from column 3 of item 516 in Subdivision 1 of Division 2 of Part 2 and substituting "novice driver learner stage";
- (f) by inserting after item 520 in Subdivision 1 of Division 2 of Part 2 the following item:

520A. DLVR Novice driver, or novice rider, in P2 stage fail to display clearly visible P-plates as required

- (g) by inserting "or P2 stage" after "stage" in column 3 of item 521 in Subdivision 1 of Division 2 of Part 2;
- (h) by inserting after item 521 in Subdivision 1 of Division 2 of Part 2 the following item:

521A.	DLVR	Holder of P1 provisional licence, in relation to a	1.25	2
	12A(1)	vehicle other than a motor cycle, transporting		
		more than one passenger, who has attained the
