1. Short title

These regulations may be cited as the Vehicle and Traffic (Driver Licensing and Vehicle Registration) Amendment Regulations (No. 2) 2021.

2. Commencement

- (1) Except as provided in this regulation, the provisions of these regulations take effect on the day on which the making of these regulations is notified in the *Gazette*.
- (2) Part 3 takes effect on the day on which the *Vehicle and Traffic (Review of Decisions) Regulations 2021* commence.

3. Principal Regulations

In this Part, the Vehicle and Traffic (Driver Licensing and Vehicle Registration) Regulations 2021* are referred to as the Principal Regulations.

4. Regulation 173 amended (National heavy vehicle number plate fee)

Regulation 173 of the Principal Regulations is amended as follows:

- (a) by omitting subregulation (4) and substituting the following subregulation:
 - (4) For the financial year ending 30 June 2022, the national heavy vehicle number plate fee is \$26.10.
- (b) by inserting in subregulation (6) "divided by the Australian CPI number for the December quarter in 2020" after "that financial year".

Regulation 41(2) of the Principal Regulations is amended by omitting "Vehicle and Traffic (Review of Decisions) Regulations 2010" and substituting "Vehicle and Traffic (Review of Decisions) Regulations 2021".

EXPLANATORY NOTE

(This note is not part of the regulations)

These regulations amend the Vehicle and Traffic (Driver Licensing and Vehicle Registration) Regulations 2021 by –

- (a) updating certain references consequent on the commencement of the Vehicle and *Traffic* (*Review of Decisions*) *Regulations 2021*; and
- (b) specifying the fee payable in respect of a heavy vehicle number plate for the financial year ending on 30 June 2022.
