3. Corresponding laws

For the purposes of the definition of *corresponding law* in section 3 of the *Police Powers (Assumed Identities) Act 2006*, the following laws of other jurisdictions are declared to correspond to that Act:

- (a) *Crimes (Assumed Identities) Act 2009* of the Australian Capital Territory;
- (b) *Law Enforcement and National Security (Assumed Identities) Act 2010* of New South Wales;
- (c) Part 3 of the *Police (Special Investigative and Other Powers) Act 2015* of the Northern Territory;
- (d) Chapter 12 of the *Police Powers and Responsibilities Act 2000* of Queensland;
- (e) Part 3 of the *Criminal Investigation (Covert Operations) Act 2009* of South Australia;
- (f) *Crimes (Assumed Identities) Act 2004* of Victoria;
- (g) Part 3 of the *Criminal Investigation (Covert Powers) Act 2012* of Western Australia;
- (h) Part IAC of the *Crimes Act 1914* of the Commonwealth.

These regulations –

- (b) rescind the *Police Powers (Assumed Identities) (Corresponding Laws) Regulations 2010* and the *Police Powers (Assumed Identities) (Corresponding Laws) Amendment Regulations 2012*.
