# TRAFFIC (COMPLIANCE AND ENFORCEMENT) AMENDMENT REGULATIONS (No. 2) 2021

## 1. Short title

These regulations may be cited as the *Traffic* (Compliance and Enforcement) Amendment Regulations (No. 2) 2021.

#### 2. Commencement

These regulations take effect on the day on which their making is notified in the *Gazette*.

## 3. Principal Regulations

In these regulations, the *Traffic (Compliance and Enforcement) Regulations 2017\** are referred to as the Principal Regulations.

## 4. Schedule 1 amended (Offences)

Division 2 of Part 1 of Schedule 1 to the Principal Regulations is amended as follows:

- (a) by omitting "Motor bike" from column 3 of item 376 in Subdivision 43 and substituting "Motor bike, or quad bike,";
- (b) by omitting "Motor bike" from column 3 of item 377 in Subdivision 43 and substituting "Motor bike, or quad bike,";
- (c) by omitting "Motor bike" from column 3 of item 378 in Subdivision 43 and substituting "Motor bike, or quad bike,";
- (d) by omitting "motor bike" from column 3 of item 379 in Subdivision 43 and substituting "motor bike, or quad bike,";
- (e) by omitting "motor bike" from column 3 of item 380 in Subdivision 43 and substituting "motor bike, or quad bike,";
- (f) by omitting "motor bike" from column 3 of item 383 in Subdivision 43 and substituting "motor bike, or quad bike,";

These regulations amend the *Traffic (Compliance and Enforcement) Regulations 2017* by –

- (a) including references to quad bikes in relevant provisions to reflect changes to the *Road Rules* in respect of quad bikes; and
- (b) prescribing two new offences, relating to quad bikes, for which an infringement notice may be issued under the *Traffic Act 1925*.
