1. Short title

This notice may be cited as the *Strategic Infrastructure Corridors (Strategic and Recreational Use) (North East Corridor from Lilydale Falls to Tonganah) Amendment Notice 2022*.

2. Commencement

This notice takes effect on the day after the day on which its making is notified in the *Gazette*.

Clause 3 of the Principal Notice is amended by omitting “on Plan 10396 in the Central Plan Register to be land within a corridor” and substituting “as Area 1 on Amended Plan, Revision No. 1, of Plan 10396 in the Central Plan Register, to be land within a corridor,”.

This notice amends the *Strategic Infrastructure Corridors (Strategic and Recreational Use) (North East Corridor from Lilydale Falls to Tonganah) Notice 2020* by clarifying the status of certain public access roads within the North East Corridor from Lilydale Falls to Tonganah.
