**1. Short title**

These regulations may be cited as the *Traffic (Compliance and Enforcement) Amendment (Passenger Transport) Regulations 2022*.

**2. Commencement**

These regulations take effect on the day on which the *Passenger Transport Services Amendment Regulations 2022* commence.

### 3. Principal Regulations

In these regulations, the *Traffic (Compliance and Enforcement) Regulations 2017\** are referred to as the Principal Regulations.

### 4. Schedule 1 amended (Offences)

Schedule 1 to the Principal Regulations is amended as follows:

- (a) by omitting item 784 from Subdivision 3 of Division 2 of Part 3 and substituting the following:

- (b) by omitting items 785, 786, 787, 788, 789, 790, 791 and 792 from Subdivision 3 of Division 2 of Part 3;

- (d) by omitting items 863, 864, 865, 866, 867, 868, 869, 870, 871, 872, 873, 874, 875, 876, 877, 878 and 879 from Subdivision 6 of Division 2 of Part 3;
- (e) by omitting Part 4.
