PROCLAMATION UNDER THE NATURE CONSERVATION ACT 2002

STATUTORY RULES 2023, No. 7

I, the Governor in and over the State of Tasmania and its Dependencies in the Commonwealth of Australia, acting with the advice of the Executive Council, by this my proclamation made under section 11(2) of the *Nature Conservation Act* 2002 declare –

- (a) the Crown land specified in Part 1 of Schedule 1 to this proclamation to be reserved land in the class of regional reserve and give the name Dogs Head Hill Regional Reserve to that reserved land; and
- (b) the Crown land specified in Part 2 of Schedule 1 to this proclamation to be reserved land in the class of conservation area and give the name Great Western Tiers Conservation Area to that reserved land; and
- (c) the Crown land specified in Part 3 of Schedule 1 to this proclamation to be reserved land in the class of conservation area and give the name Great Western

Tiers Conservation Area to that reserved land; and

- (d) the Crown land specified in Part 4 of Schedule 1 to this proclamation to be reserved land in the class of conservation area and give the name Great Western Tiers Conservation Area to that reserved land; and
- (e) the Crown land specified in Part 5 of Schedule 1 to this proclamation to be reserved land in the class of conservation area and give the name Great Western Tiers Conservation Area to that reserved land; and
- (f) the Crown land specified in Part 6 of Schedule 1 to this proclamation to be reserved land in the class of conservation area and give the name Great Western Tiers Conservation Area to that reserved land; and
- (g) the Crown land specified in Part 7 of Schedule 1 to this proclamation to be reserved land in the class of conservation area and give the name Great Western Tiers Conservation Area to that reserved land; and
- (h) the Crown land specified in Part 8 of Schedule 1 to this proclamation to be reserved land in the class of conservation area and give the name Liffey

Conservation Area to that reserved land; and

- (i) the Crown land specified in Part 9 of Schedule 1 to this proclamation to be reserved land in the class of conservation area and give the name Southwest Conservation Area to that reserved land; and
- (j) the Crown land specified in Part 10 of Schedule 1 to this proclamation to be reserved land in the class of conservation area and give the name Stringybark Conservation Area to that reserved land; and
- (k) that this proclamation takes effect on the day on which its making is notified in the *Gazette*.

SCHEDULE 1 – AREAS OF LAND

PART 1 – DOGS HEAD HILL REGIONAL RESERVE

All that area of land comprising about 146.4 hectares, shown as Lot 1 and bounded by a heavy black line on Plan 10441 in the Central Plan Register, a reduced copy of which is set out, by way of illustration only, in Part 1 of Schedule 2 to this proclamation.

PART 2 – GREAT WESTERN TIERS CONSERVATION AREA (PART 1)

All that area of land comprising about 3 602 hectares, shown as Lot 1 and bounded by a heavy black line on Plan 10442 in the Central Plan Register, a reduced copy of which is set out, by way of illustration only, in Part 2 of Schedule 2 to this proclamation.

PART 3 – GREAT WESTERN TIERS CONSERVATION AREA (PART 2)

All that area of land comprising about 1 987 hectares, shown as Lot 1 and bounded by a heavy black line on Plan 10443 in the Central Plan Register, a reduced copy of which is set out, by way of illustration only, in Part 3 of Schedule 2 to this proclamation.

PART 4 – GREAT WESTERN TIERS CONSERVATION AREA (PART 3)

All that area of land comprising about 741.4 hectares, shown as Lot 1 and bounded by a heavy black line on Plan 10446 in the Central Plan Register, a reduced copy of which is set out, by way of illustration only, in Part 4 of Schedule 2 to this proclamation.

PART 5 – GREAT WESTERN TIERS CONSERVATION AREA (PART 4)

All that area of land comprising about 2 616 hectares, shown as Lot 1 and bounded by a heavy black line on Plan 10447 in the Central Plan Register, a reduced copy of which is set out, by way of illustration only, in Part 5 of Schedule 2 to this proclamation.

PART 6 – GREAT WESTERN TIERS CONSERVATION AREA (PART 5)

All that area of land comprising –

- (a) about 2 767 hectares, shown as Lot 1; and
- (b) about 545.7 hectares, shown as Lot 2; and
- (c) about 1.120 hectares, shown as Lot 3 –

bounded by heavy black lines on Plan 10448 in the Central Plan Register, a reduced copy of which is set out, by way of illustration only, in Part 6 of Schedule 2 to this proclamation.

PART 7 – GREAT WESTERN TIERS CONSERVATION AREA (PART 6)

All that area of land comprising about 433.8 hectares, shown as Lot 1 and bounded by a heavy black line on Plan 11136 in the Central Plan Register, a reduced copy of which is set out, by way of illustration only, in Part 7 of Schedule 2 to this proclamation.

PART 8 – LIFFEY CONSERVATION AREA

All that area of land comprising about 35.08 hectares, shown as Lot 1 and bounded by a heavy black line on Plan 10445 in the Central Plan Register, a reduced copy of which is set out, by way of illustration only, in Part 8 of Schedule 2 to this proclamation.

PART 9 – SOUTHWEST CONSERVATION AREA



PART 10 – STRINGYBARK CONSERVATION AREA




PART 1 – DOGS HEAD HILL REGIONAL RESERVE




PART 2 – GREAT WESTERN TIERS CONSERVATION AREA (PART 1)




PART 3 – GREAT WESTERN TIERS CONSERVATION AREA (PART 2)




PART 6 – GREAT WESTERN TIERS CONSERVATION AREA (PART 5)






PART 8 – LIFFEY CONSERVATION AREA

EXPLANATORY NOTE

(This note is not part of the proclamation)

This proclamation, under the *Nature Conservation Act* 2002 –

- (a) declares
 - (i) a certain area of Crown land to be reserved land in the class of regional reserve; and
 - (ii) certain areas of Crown land to be reserved land in the class of conservation area; and
- (b) in doing so, creates a new regional reserve and certain new conservation areas and extends an existing conservation area.
