**1. Short title**

These regulations may be cited as the *Vehicle and Traffic (Review of Decisions) Amendment Regulations 2024*.

**3. Principal Regulations**

In these regulations, the *Vehicle and Traffic (Review of Decisions) Regulations 2021\** are referred to as the Principal Regulations.

**4. Schedule 1 amended (Administrative Decisions and Eligible Persons)**

Schedule 1 to the Principal Regulations is amended as follows:

- (a) by inserting “and (4)” after “49(3)” in column 3 of item 11 in Part 1;
- (b) by omitting “(1)” from column 3 of item 17 in Part 1 and substituting “(2)”;
- (c) by omitting Part 2 and substituting the following Part:
