1. Short title

These regulations may be cited as the *Traffic (Compliance and Enforcement) Amendment (Helmets) Regulations 2025*.

2. Commencement

These regulations take effect on the day on which the *Road Amendment (Helmet) Rules 2025* commence.

3. Principal Regulations

In these regulations, the *Traffic (Compliance and Enforcement) Regulations 2017** are referred to as the Principal Regulations.

4. Schedule 1 amended (Offences)

Division 2 of Part 1 of Schedule 1 to the Principal Regulations is amended as follows:

- (a) by omitting item 328N from Subdivision 41A and substituting the following item:

328N.	RR 244L(1)	PMD user fail to wear securely fitted and fastened approved bicycle helmet unless exempt	0.75	0

- (b) by omitting items 349, 350 and 351 from Subdivision 42 and substituting the following items:

349.	RR 256(1)	Rider of bicycle fail to wear securely fitted and fastened approved bicycle helmet unless exempt	0.75	0
350.	RR 256(2)	Bicycle passenger (except fare-paying passenger on 3 or 4-wheeled bicycle) fail to wear securely fitted and fastened approved bicycle helmet unless exempt	0.25	0
351.	RR 256(3)	Rider of bicycle carry passenger (except fare-paying passenger on 3 or 4-wheeled bicycle) without securely fitted and fastened approved bicycle helmet unless exempt	0.75	0
