PART 1 – PRELIMINARY

1. Short title

This Act may be cited as the *Justice Miscellaneous (Administrative Review Tribunal) Act 2025*.

2. Commencement

This Act commences on the day on which the *Administrative Review Tribunal Act 2024* of the Commonwealth commences but, if that Act commences before this Act receives the Royal Assent, this Act is taken to have commenced on the day on which the *Administrative Review Tribunal Act 2024* of the Commonwealth commenced.
