## **RESTRICTED HIRE VEHICLE INDUSTRY AMENDMENT REGULATIONS 2018**

### **1. Short title**

These regulations may be cited as the *Restricted Hire Vehicle Industry Amendment Regulations 2018*.

### **2. Commencement**

These regulations take effect on the day on which the *Taxi Industry Regulations 2018* commence.

### **3. Principal Regulations**

In these regulations, the *Restricted Hire Vehicle Industry Regulations 2013*\* are referred to as the Principal Regulations.

### **4. Regulation 3 amended (Interpretation)**

Regulation 3 of the Principal Regulations is amended as follows:

- (a) by omitting the definition of *registration plate* and substituting the following definition:

*registration plate* means a number plate issued by the Registrar under the *Vehicle and Traffic Act 1999* in respect of a vehicle's registration under that Act;

- (b) by omitting “*Taxi Industry Regulations 2008*” from the definition of *security camera system* and substituting “*Taxi Industry Regulations 2018*”.

### **5. Regulation 13 amended (Installation of security camera)**

Regulation 13(3) of the Principal Regulations is amended by omitting “*Taxi Industry Regulations 2008*” and substituting “*Taxi Industry Regulations 2018*”.
