LOCAL GOVERNMENT (MUNICIPAL BOUNDARY AREA ADJUSTMENT) ORDER 2018

1. Short title

This order may be cited as the *Local Government (Municipal Boundary Area Adjustment) Order 2018*.

2. Commencement

This order takes effect on the day on which its making is notified in the *Gazette*.

3. Adjustment of boundaries of municipal areas

For the purposes of section 16(5) of the *Local Government Act 1993* –

- (a) the boundary of the George Town municipal area is adjusted by including all the land situated at 2377 and 2405 East Tamar Highway at Mount Direction in Tasmania, comprised in Volume 153083 Folio 2 of the Register kept under section 33 of the *Land Titles Act 1980*, as part of that municipal area; and
- (b) the boundary of the Glenorchy municipal area is adjusted by including all the area of land shown as City of Glenorchy, and bounded by a heavy black line on CPR 9815 in the Central Plan Register, as part of that municipal area; and
- (c) the boundary of the Hobart municipal area is adjusted by including all the area of land shown as City of Hobart, and bounded by a heavy black line on CPR 9814 in the Central Plan Register, as part of that municipal area; and
- (d) the boundary of the Launceston municipal area is adjusted by including all the land situated at 760 Pipers Brook Road at Pipers Brook in Tasmania, comprised in Volume 33837 Folio 2 of the Register kept under section 33 of the *Land Titles Act 1980*, as part of that municipal area.
