1. Short title

These regulations may be cited as the *Plant Quarantine Amendment Regulations 2019*.

2. Commencement

These regulations take effect on the day on which their making is notified in the *Gazette*.

3. Principal Regulations

In these regulations, the *Plant Quarantine Regulations 2017** are referred to as the Principal Regulations.

4. Regulation 4 amended (Fees and charges payable under Act)

Regulation 4(4) of the Principal Regulations is amended by omitting “GST inclusive” and substituting “exclusive of GST”.

5. Schedule 1 amended (Fees and Charges)

Schedule 1 to the Principal Regulations is amended by omitting Parts 1 and 2 and substituting:

EXPLANATORY NOTE

(This note is not part of the regulations)

These regulations amend the *Plant Quarantine Regulations 2017* by –

- (a) increasing the prescribed fees payable in respect of the examination of documents or a vessel or on provision of a certificate of release; and
- (b) providing that the fees specified in the regulations are exclusive of GST.
