**LITTER (INFRINGEMENT OFFENCES)

**1. Short title**

These regulations may be cited as the *Litter (Infringement Offences) Regulations 2020*.

**2. Commencement**

These regulations take effect on the day on which their making is notified in the *Gazette*.

**3. Interpretation**

In these regulations –

*Act* means the *Litter Act 2007*.

**4. Infringement offences and penalties**

For the purposes of section 17 of the Act –

- (a) an offence specified in column 2 of the table in Schedule 1 is prescribed as an infringement offence for the purposes of infringement notices; and
- (b) the penalty specified in column 3 of that table for that infringement offence is the penalty that is payable by a natural person under an infringement notice in respect of that offence; and
- (c) the penalty specified in column 4 of that table for that infringement offence is the penalty that is payable by a body corporate under an infringement notice in respect of that offence.

**5. Legislation rescinded**

The legislation specified in Schedule 2 is rescinded.
