1. Short title

These regulations may be cited as the *Gaming Control (Infringement Notices) Regulations 2021*.

2. Commencement

These regulations take effect on 27 April 2021.

3. Interpretation

In these regulations –

Act means the *Gaming Control Act 1993*.

4. Infringement notice offences and penalties

For the purposes of section 172A of the Act –

- (a) an infringement offence is an offence against a provision of the Act specified in column 2 of Schedule 1; and
- (b) the penalty specified in column 3 of Schedule 1 in relation to an infringement offence is the penalty applicable to that offence.
