1. Short title

These rules may be cited as the *Road Amendment Rules 2021*.

2. Commencement

These rules take effect on the day on which the *Vehicle and Traffic (Driver Licensing and Vehicle Registration) Regulations 2021* commence.

3. Principal Rules

In these rules, the *Road Rules 2019** are referred to as the Principal Rules.

4. Rule 151A amended (Lane filtering on a motor bike)

Rule 151A(6) of the Principal Rules is amended by omitting “*Vehicle and Traffic (Driver Licensing and Vehicle Registration) Regulations 2010*” from the definition of *motor cycle licence* and substituting “*Vehicle and Traffic (Driver Licensing and Vehicle Registration) Regulations 2021*”.

5. Rule 300 amended (Use of mobile phones)

Rule 300(4) of the Principal Rules is amended by omitting “*Vehicle and Traffic (Driver Licensing and Vehicle Registration) Regulations 2010*” from the definition of *car licence* and substituting “*Vehicle and Traffic (Driver Licensing and Vehicle Registration) Regulations 2021*”.

6. Rule 373 amended (Speed-limits for learners and provisional licensees)

Rule 373(4) of the Principal Rules is amended by omitting “*Vehicle and Traffic (Driver Licensing and Vehicle Registration) Regulations 2010*” from the definition of *motor cycle licence*

and substituting “*Vehicle and Traffic (Driver Licensing and Vehicle Registration) Regulations 2021*”.

7. Schedule 5 amended (Dictionary)

Clause 1 of Schedule 5 to the Principal Rules is amended by omitting “*Vehicle and Traffic (Driver Licensing and Vehicle Registration) Regulations 2010*” from the definition of *P1 provisional licence* and substituting “*Vehicle and Traffic (Driver Licensing and Vehicle Registration) Regulations 2021*”.
